1. This is a submission on the Proposed Regional Land and Water Plan ("the Proposed Plan").
2. The specific provisions of the proposal that the submission relates to are:
 - a. The Proposed Plan in its entirety.
3. The submission is:
 - a. The submitter supports the Proposed Plan. The merger of the Council's three resource management plans (Proposed Land and Riverbed Management Plan; Proposed Water Management Plan, and Regional Plan for Discharges to Land) into one plan, will provide greater efficiency and ease of use.
