

(Estate of HOLLIS Beryl Teresa - Peter Hollis resident) Comments on Opinion Survey -Advanced Flood Warning System for Westport In a recent letter to the editor of The News, Westport, I criticized your submission process for a rating district/consultation for the above flood warning system, for not providing advance information by way of a This was as much of intellectual interest to me as anything. It did not mean I was necessarily opposed to the proposal in principle. After all, prior to WCRC's 2017 flood consultation in Westport The News carried an advance article on the scheme in detail('Flood Protection Options Revealed' -The News 13.1.17). Also, the well-designed flyer for the consultation also included a section on a proposed upgrade of the Difference of the Buller Buller River flood warning system - Hydro Site Upgrade for the Buller River Catchment' -which gave a good summary of how this worked, accessible to the layperson and not using technical terms such as 'telemetry'. I find the rating proposal to fund the system -\$7.90(GST incl.) per \$100,000 of capital value over three years very reasonable -if I understand it correctly, around \$40 for a \$500,000 value house/price of a decent restaurant meal and drink. I think it's extraordinary there is such a problem with this, but earlier attempts to reform rates towards CV by Buller District Council have illustrated the opposition to CV rating here that exists in pronciple, despite inequities affecting those on fixed incomes in low value homes BDC had been hoping to address. It seems there is no perfect rating system, and I incline toward acting WCRC acting chief executive Robert Mallinson's definition of 'a reason-able community of interest' (News 22.9.20).Some people in wealthier areas are sympathetic, some opposed. However in your proposed rating disrict, clearly not all enclosed areas can be said to be 'benefiting parties' e.g Alma Road as they are not at flood risk -though I appreciate the

argument that people close to town use the town's facilities. It's a strong point that a rating district has been a precondition for

other coast communities obtaining flood protection funding and will be into the future. However our mayor seems now to be wary of Westport being locked into a rigid format like this .Also, there seems to be ongoing tension between WCRC and BDC as to leadership responsibilities/roles in Westport flood protection.

The map of the proposed rating district coloured in blue seemed to imply that this area as a whole was at flood risk, which isn't the case. Also, your letter didn't say why Westport's \$10m flood protection scheme didn't meet the requirements of the Crown Infrastructure Project.

Westport's next step of building actual flood protection will likely be contentious given the strong disagreement on the value of dredging or clearing overflows & valves and stopbank options.But I thnk many share Chris Coll's disquiet at the atypical calm of the Buller River for so long now...like an old-time movie: 'I don't like it..it's too quiet'.





ADVANCED FLOOD WARNING SYSTEM FOR WESTPORT

This submission is in opposition to the proposed flood warning system and new Westport rating system.

There is already a basic flood warning system in place for Westport with gauges on the various tributaries and an alert system when these gauges trigger set levels and which therefore already allows time to alert residents in affected areas. This money would be better spent planning and implementing a flood mitigation system for Westport.

We own land collectively amalgamated under three different valuation numbers – 1884015500, 1884015200 and 1884015402 which consists of farm land plus two barns apart from our dwelling which is located on the north side of Beach Road which is outside the proposed rating area but has been included in the area according to the supplied map. The suggestion that the rating area has been created to include the residents of Westport **AND** those residents outside this area <u>who use the services of Westport</u> is completely flawed.

There are numerous small holdings with dwellings located on Powerhouse Road as well as a subdivision of houses and a farmhouse located off Beach Road, Fairdown who utilise the services of Westport and which have not been included in the proposed rating area. I also not that the area on the other side of the state highway south of Carters Beach has also been excluded from the proposed rating area even though this area is much closer to Westport and the residents therefore being more likely to be using the 'services of Westport' than ourselves.

The creation of a new flood warning system for Westport will not have any beneficial impact on our property.
