3. CONFIRMATION OF MINUTES

REPORTS:

4.1 PLANNING AND ENVIRONMENTAL MANAGER'S REPORT ON ENGINEERING OPERATIONS

S. Moran took his report as read but drew attention to the table of total for rock movement stating that this is incorrect. The correct figure for rock used is 5060 and for rock in quarry the correct figure is 16,438.

Cr Chinn queried whether the tender to be let for the future works at the Wanganui quarry would be based on the new or old rock price. S. Moran advised that this rock is from the stockpile on the riverbank therefore it would be at the old price.

The second (tabled) report recommended new rock prices to take effect after 1 July 2008.

4.2 VECTOR PROGRAMME MANAGER'S REPORT

C. Pullen spoke to his report. He advised that all contracts for 2007 / 2008 have been awarded and are presently being undertaken. There have been no failures to date. C. Pullen advised that 95% of the programme should be complete by the end of the financial year. He advised that the good weather has helped with both aerial and ground control programmes. The planning for the 2008 / 2009 vector programme is progressing well.

4.3 CORPORATE SERVICE MANAGER'S REPORT

R. Mallinson spoke to this report. He advised that the results are similar to those reported at the March meeting. He spoke of various highlights in this report including the value of the investment portfolio declined by a further \$24,000. R. Mallinson commented that it is encouraging to see overseas markets now starting to rise during April. He spoke of the continuing positive budget variances amounting to \$174,000. He advised that the second rate installment date is the 20^{th} of April.

R. Mallinson was congratulated on being awarded the Society of Local Government Managers Overseas Manager Exchange to the USA.

4.3.1 EIGHT MONTH REVIEW OF 2007 / 2008 ANNUAL PLAN

R. Mallinson spoke to this report and took it as read. Cr Archer passed on his compliments to staff on a good result. C. Ingle stated that by having these reports enables management to track progress. Cr Birchfield commented that it is pleasing to see resource consents being processed so promptly and that Council is performing well.

4.0 CHIEF EXECUTIVES REPORT

C. Ingle spoke to his report and advised that he has met with consultants working for EECA (Energy Efficiency Conservation Authority). This was to discuss preparation of a strategy for the development of renewable energy sources for the West Coast. C. Ingle likened this to a stocktake of the opportunities for renewable energy for the future. It is hoped that when this

project is complete the information will be used by energy companies to look at the best options for them.

- C. Ingle advised that he met with Keith Brodie from Minerals West Coast to discuss the minerals resource assessment for the region. Mr Brodie is talking with Development West Coast to get funding to further this matter. This will allow an overview as to where these resources are and to make sure that inappropriate planning impediments are not put in the way of developing these resources.
- C. Ingle met with the CEO of Westland District Council. Local topics were discussed to ensure that both councils are heading in the same direction with these matters.
- C. Ingle accompanied Cr Ewen to meet with Hon. Trevor Mallard in Hokitika to discuss local issues.
- C. Ingle attended the Transit Hearing in Hokitika relating to Transit's 10 year draft plan where he complimented them on the Arahura Bridge development. C. Ingle advised that this is one of Transit's major projects in New Zealand and that the West Coast is doing well in the transport area by lobbying Transit to get these projects on the national books. He advised that there is a strategy being developed for passing opportunities on the West Coast.
- C. Ingle reported that Transit is merging the LTNZ very shortly.
- C. Ingle reported that council's IT Strategy that has been developed. This was a very useful process to gain a longterm overview as to what Council's needs are for the future.
