In respect to the Karamea situation the investigation of a new quarry site would be paid out of the uniform charge paid throughout the West Coast for rock removed from quarries administered by the West Coast Regional Council.

The setting of quarry charges was done through the Councils Annual Plan process and was presently set at \$4.00 + GST per tonne of rock extracted.
