WORKS REPORT

There was a general discussion as to what works were required for the coming financial year.

It was identified that some drain spraying will be required to be carried out on Lee Kees property in December.

Mike Jones reported that the fibreglass floodgate on Blackwater Creek needed to be repaired or replaced.

R. Lowe to organise its replacement or repair.

There was some discussion regarding the cleanout of the Little Wanganui River mainly related to removing any willow obstructions.

It was agreed that the committee would discuss with the adjacent landowners along the Little Wanganui River as to the removal of any obstruction of water entering the Kongahu Development Area.

Russell Anderson raised the issue regarding the Management Plan for the Kongahu Swamp drafted by Phillippe Gerbeaux of the Department of Conservation which had been circulated for comment.

R. Lowe informed the meeting that Operations Section of the West Coast Regional Council had not seen the draft and could offer no comment in respect to its contents.

The outcome of this was a copy of the report would be requested and followed up with the Committee at a later date.

There was some discussion regarding the placement of drain spoil over an access road over an approximate distance of 400 metres.

It was also noted that two side creeks had contributed to part filling in of one of the main creeks.

It was agreed both these issues would be looked into as being part of next years works programme.
