## BUSINESS

J. Wood opened the meeting and welcomed those present.

## **MATTERS ARISING**

W. Moen outlined the proposed Rating District in detail and explained that the capital value based classification appeared to be the fairest way of sharing the rate burden over the area.

He also explained that the area had been slightly expanded to take in some areas that in the past had not been included, but had received benefit from the existing works. He also outlined the common boundary between the Canavan's Knob and the Lower Waiho Rating Districts and advised that this had been modified slightly to accommodate property boundaries.

J. Wood outlined the new appeal processes set out in the Annual Plan and advised those present to utilise the system in June / July.

Moved: "That the ratepayers endorse the staff's action to date and that the reclassification as presented be approved for inclusion in the draft Annual Plan."

## RATES 2003 / 2004

W. Moen again outlined his concerns at the ongoing deficit situation for the rating District given the potential extra works required at the top end of the Rubbish Dump bank in the very near future.

He explained that, in his view, evidence of the river flows through the area were increasing rapidly and work on the consented upper stopbank should be viewed as urgent.

# Moved: "That the rates strike for the 2003 / 2004 financial year be set at \$28,000 + GST."
