

Permitted activities that require notification to the West Coast Regional Council	
Land & Water Plan Rule	Conditions
Permitted activities on land	
Rule 1. Humping and hollowing, flipping, or v-blading outside riparian margins.	<i>Condition 1(i)</i> “The Council is notified in writing of the location and extent of the activity, at least seven working days prior to the works commencing.”
Rule 3. Earthworks in the Non-Erosion prone area, outside riparian margins.	<i>Condition 3(k)</i> “Where the earthworks are for the purpose of constructing a water supply bore the Council must be notified within five working days of the location depth and purpose of the bore.”
Rule 7. Earthworks and associated vegetation disturbance within a Schedule 2 wetland.	<i>Condition 7(a)(viii)</i> “Council is notified seven days prior to the activity taking place.”
	<i>Condition 7(b)(x)</i> “Council is notified seven days prior to the activity taking place.”
	<i>Condition 7(d)(ix)</i> “Council is notified seven days prior to the activity taking place.”
	<i>Condition 7(e)(xi)</i> “Council is notified seven days prior to the activity.”
Regulation 55(2) of the National Environmental Standards for Freshwater (NESF).	The NESF requires notification to the Council at least 10 working days before starting the activity.
Rule 7a. Harvesting of Sphagnum Moss within Schedule 2 wetland.	<i>Condition 7a.(a)</i> “The Council is notified in writing of the location of the activity and the area to be harvested at least seven working days prior to the activity taking place.”
Regulation 48 (2)(a) of the National Environmental Standards for Freshwater (NESF).	The NESF requires a harvesting plan to be provided at least 20 working days prior to the activity.
Permitted activities in riverbeds and lakes	
Rule 24. Structures for damming water	<i>Condition 24(f)</i> “The Council is notified in writing of the location and nature of the dam, at least seven working days prior to commencing the erection or placement.”
Rule 25. Other structures	<i>Condition 25(c)</i> The Council is notified in writing of the location and nature of the structure, at least seven working days prior to commencing the erection or placement.”

Rule 26. Alteration of the bed associated with structures, or the clearance of debris or gravel	Condition 26(g)(viii) "Council is to be notified seven days prior to commencing any bed disturbance, including deposition or reclamation associated with any placement erection or reconstruction referred to in Rule 26(g)(i)."
Rule 29. Gravel extraction	Condition 29(a) "Persons wishing to remove gravel must notify the Regional Council in writing of the location, size and timing of the take prior to the take occurring;"
Permitted takes, uses, diversions, and damming of water	
Rule 39. Take and use of water from listed sources	Condition 39(d) "The Council is informed in writing of the location, expected rate and frequency of the take prior to the take occurring and contact details of the person taking."
Rule 40. Take and use of water where not permitted by Rule 39	Condition 40(d) "The Council is informed in writing of the location, expected rate and frequency of the take prior to the take occurring and contact details of the person taking."
Rule 41. Water take and use or diversion for small scale hydro electricity generation	Condition 41(e) "The Council is informed in writing of the location, expected rate and frequency of the take prior to the take occurring, and contact details of the person taking water."
Rule 43. Transfer of a water permit	Condition 43(b) "Written notice signed by the transferor and transferee is given within 14 days to the Council, specifying ..." (i) to (vi).
Rule 44. Take and use of groundwater	Condition 44(g) "The council is informed in writing of the location, expected rate and frequency of the take prior to the take occurring and contact details of the person taking."
Rule 47 Temporary diversion of water	Condition 47(f) "At least seven days prior to the diversion occurring the Council is provided with a plan showing the proposed works in relation to the river flow and bed form, and a photo of the area of river to be diverted taken from a fixed reference point, and within seven days of the completion of the works a second photo is provided to the Council taken from the same fixed reference point."

Rule 50. Damming of water	Condition 50(f) "Council is informed in writing of the location of the dam and the method of construction proposed, at least seven days prior to commencing the erection or placement of the dam."
Permitted discharges to land	
Rule 78. Application of agrichemical substances on areas other than domestic properties	Condition 78(g) "The discharger immediately notifies the Regional Council in the event of any accidental discharge of any agrichemical."
